- Puppy/Dog is a purebred Cardigan Welsh Corgi.
- This puppy/dog is guaranteed to be of good Temperament at the time of sale. Breeder has no control over the environment in which dog will live after it leaves my home.
- This puppy/dog is guaranteed to be of good general health at the time of sale. Breeder has no control over the environment in which dog will live after it leaves my home
- This animal is guaranteed to be free of all hereditary - congenital defects, to the best of my knowledge that would make it unsuitable as a pet/companion.
- We can not guarantee that the above mentioned puppy/dog does not carry a hereditary - congenital defect
- This puppy/dog’s parent(s) that is owned by Qwaynt Cardigans is OFA Certified as free of hip dysplasia.
- I also guarantee that I will Take the puppy/dog back for the life of the dog

HEALTH

- All precautions have been made to insure that this puppy is in excellent health at the time of purchase including vaccinations, and deworming on a regular basis and according to the age of the puppy/dog.
- It is recommended that the Buyer take the puppy to a Veterinarian, of his/her choice, within seven (7) days from the date of delivery of the puppy.
- If, within seven days, a veterinarian finds the puppy to be unsound, unhealthy or possess serious hereditary and/or congenital defect. A statement in writing must be provided to the Breeder by that veterinarian documenting said condition. Breeder will have the right to ask for a second opinion from a second veterinarian for hereditary and/or congenital defect. Buyer may return the puppy with all of his/her effects to the Breeder and receive a full, immediate refund of the purchase price. All transportation costs involved are the responsibility of the Buyer.
- Breeder cannot guarantee anything caused by environmental hazards (injuries and illnesses caused by accidents or by improper supervision) after it leaves my home
- This puppy is guaranteed not to develop PRA, as both of the parents are negative for the gene through DNA Testing or through DNA tested bloodlines.
- This puppy/dog is expected to be free of hereditary crippling hip dysplasia, however no guarantees can be made that this puppy/dog will not develop hip dysplasia, because of the polygenetic, nutritional, and environmental conditions of hip dysplasia.

Buyer Agreement to:

1. To spayed or neutered between 78 and 9 months of age.
 - If female puppy becomes pregnant, Breeder/seller has the right to remove female dog with all her puppies for breach of contract with all AKC registration papers and litter forms.
2. To abide by all state and local laws regarding the licensing, leashing and other ordinances regarding pet ownership.
3. Register the Avid Microchip number with Avid Pet Trac, by using the provided form.
4. Allow Qwaynt Cardigans to use photos, literature and any titles earned for advertising purposes.

The Buyers shall:

1. Provide proper Nutrition
2. Provide regular exercise
3. Provide regular Veterinary care
4. To prevent illness and injury to the puppy/dog
5. Provide Heartworm check; properly administer heartworm preventatives; daily or monthly. It is the buyer's responsibility to follow a veterinarian's good advice regarding **on going prevention necessary after purchase.**
6. Provide indoor housing. NEVER TO BE KEPT ON A CHAIN IN THE BACKYARD
7. Buyer agrees that you are not involved in puppy brokerage or commercial mass puppy producing (this includes any practice involving dogs being bred or sold for profit).
8. Buyer is not involved with any type of Dog fighting ring and this Cardigan Welsh Corgi will never be used as a bait dog or for training of any other dog to fight.
9. *Buyer finds he cannot keep or maintain this puppy / dog, at any time it will be return to breeder/ seller ** _____ Sign here*
10. *Buyer will never put this dog in an animal shelter for any reason. ** _____ sign here*
 ** *Buyer agrees to return said puppy/dog described above back to breeder, with signed registration papers, for replacement in a home of the breeders choosing. Expenses of returning puppy/dog are the responsibility of the buyer*
11. *The dog is not to be placed with a third party under any circumstances. Dog /Puppy placed with anyone but buyer will lead to legal actions.. Buyer will be responsible for all the legal expenses.. _____ sign here*
12. Any injury to property, household or persons done by this puppy/dog will be the sole responsibility of the buyer(s). Breeder shall NOT be obligated to any loss, damages or costs and expenses, relating to any claims, proceedings, or investigations done, by this puppy/dog when in the possession of buyer.
13. Buyer agrees to complete a Basic Obedience course with this puppy/dog through a licensed Training club or center.
14. It is the buyer's responsibility to continue scheduled vaccinations, deworming and general health problems with a licensed Veterinarian.
15. **This contract shall be interpreted and governed by the laws of the State of Minnesota and jurisdiction and venue to resolve any dispute shall be within the County of Martin.**
